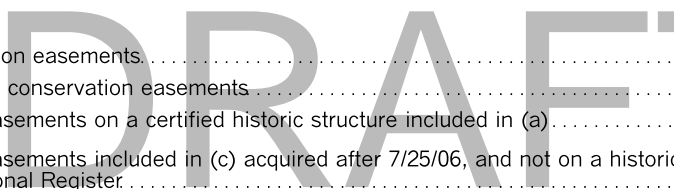

THIS 23-ACRE SITE HAS BEEN IMPROVED WITH MITIGATION FUNDING FOR IMPACTS TO REGIONAL WETLANDS. STARTING IN 2010, THREE NEW PONDS CREATED 1.25 ACRES OF OPEN WATER. IN LATE 2015 AND EARLY 2016, FIVE ACRES AT THE NORTH END OF THE SITE WERE ENCLOSED WITH DEER FENCING, SEEDED WITH A NATIVE GRASS MIX, AND PLANTED WITH OVER 5,000 TREES AND SHRUBS. IN THE SPRING, STUDENTS RELEASE THEIR FRY INTO MILL CREEK, THE TOUCHET RIVER, AND THE TUCANNON RIVER.
