STUDENTS WATCHED THEM HATCH INTO THE ALEVIN STAGE AND THEN ABSORB THEIR YOLK SACS TO BECOME FRY. DURING THE MONTHS THAT THE FISH WERE GROWING, OUR STAFF PROVIDED IN-CLASS LESSONS ON FISH ANATOMY, SALMON LIFECYCLE, WATERSHED HEALTH, AND FISH ART. THESE LESSONS WERE CONVERTED TO ONLINE LESSONS AVAILABLE FROM OUR WEBSITE AFTER SCHOOLS CLOSED DUE TO COVID. IN A TYPICAL YEAR, STUDENTS RELEASE THEIR FRY INTO MILL CREEK, THE TOUCHET RIVER, AND THE TUCANNON RIVER. DUE TO COVID RELATED SCHOOL CLOSURES, THE STUDENTS WERE UNABLE TO ATTEND FISH RELEASE EVENTS, AND INSTEAD WERE PROVIDED VIDEOS OF OUR STAFF RELEASING THEIR FISH.
